## 2020 Tick Information & Permission

Dear Camp Families,

We share your concern about ticks and want to do everything we can to prevent the possibility of tick bites. Here are some things we are doing to help with that:

- Detailed staff training on tick prevention and procedures through the Department of Health.
- Adherence to Department of Health recommendations when in grassy or wooded areas
- Minimizing the time we spend in areas where ticks are most likely to be
- Teaching campers about tick prevention and personal daily tick checks, when possible
- Should we find a tick on a camper, it will be promptly removed and parents will be called.

### Here are some things that you can do to help:

- Please send your camper with at least one outfit that includes light colored long pants, long sleeve shirt, and socks that can pull up over the pant legs. This will be what your camper will wear if s/he goes in the woods.
- Products exist that are sprayed on clothes to help repel ticks. They contain ingredients worthy of research to see if they are safe for your camper's use. You have the option of treating clothing prior to camp arrival if you deem it safe and effective for your camper.
- You may send tick repellent for your camper with their name clearly labeled on the can. **PLEASE SIGN PERMISSION BELOW.** Due to safety reasons, we are unable to share someone else's spray with your camper.

The Department of Health recommends that individuals unable to check for ticks on themselves have medical staff do it for them. Descriptions of full body tick checks and additional information can be found at
